Item number 1:

Call to order at 6:35 pm

Hold a Tax Rate Hearing and Adoption of the 2007 Tax Rate. A motion was made by Teri Wolff and seconded by Pat Donsbach to approve the property tax for 2007 at \$1.417

- \$1.027 for the purpose of maintenance and operations, and
- \$.390 for the purpose of payment of principal and interest on debts.

Item number 4:

Discuss and Consider Tax Discounts for October (3%), November (2%), and December (1%). A motion was made by Maureen West and seconded by Barry Osborne to approve the Tax Discounts as presented. The motion passed unanimously.

Item number 5:

Mr. Blincoe advised the Board of the proposed revisions to the Interdistrict Transfer Policy, FDA(Local). After Board discussion Teri Wolff made a motion and seconded by Teri Dugi to table the agenda item. The motion passed unanimously.

Item number 6:

Mr. Blincoe presented the Resolution of the Board regarding review of the Investment Program. A motion was made by Teri Wolff and seconded by Teri Dugi to approve the Resolution as presented. The motion passed unanimously.
