## Proclamation 2024

- What is it?
  - The State Board Of Education uses a proclamation to call for new instructional materials or new information about currently adopted instructional materials. The proclamation lists the subject areas scheduled for review and are named for the year the materials go into the classroom.
  - Proclamation 2024 provides for new instructional materials for Science K-12, Technology Applications, Social Studies (Personal Financial Literacy and Economics only), and several Career Development and Career and Technical Education courses.
- What is the process for Stockdale ISD?
  - Several teachers attended an instructional materials preview at Region 20's Educational Service Center in San Antonio. All teachers who teach the subjects impacted by Proclamation 2024 were given access to the instructional materials preview on TEA's website.
  - All teachers who teach the subjects impacted by Proclamation 2024 were asked to submit recommendations based on their review of the materials.
  - Teacher recommendations are made public for review by stakeholders such as parents, guardians, and community members. Those parties can then offer feedback on the proposed materials to the District Instructional Materials Coordinator.

  - The District Instructional Materials Coordinator, having received feedback from teachers and stakeholders, then presents the recommendations to the school board in a local meeting.
    - This will happen at SISD's school board meeting on March 18, 2024.
  - The District Instructional Materials Coordinator will order materials for use beginning with the 2024/2025 school year.
