DISTRICTWIDE EDUCATIONAL IMPROVEMENT COMMITTEE Minutes February 13, 2008

The Districtwide Educational Improvement Committee (DEIC) met on February 13, 2008 at 3:45 PM in the Administration Board Room. Present at the meeting were Kendra Wuest, John Martin, Sara Lyssy, Ginger Jackson, Karen Coston, Barbara Koehler, Mary Denson, Sharon West, Beverly May, Jack May, Roxanne Seidel, Brigit Lucas, Jo Ann Rodriguez, Leighanne Woodlee, Reece Blincoe, and Venicia Monita.

The meeting was called to order at 3:50 PM by Mr. Blincoe.

The committee reviewed the four 2008-2009 Calendar Options and discussed each option. The committee voted unanimously to narrow to three options.

There was discussion about C-SCOPE. There was a variety of comments about the curriculum: one school loved it; another school thought it had weak assessments. More information is needed before determining to implement C-SCOPE at Stockdale ISD. A recommendation was to visit schools that have implemented the curriculum.

2008-2009 Staff Development ideas and comments were given. Last year, it was a good idea when the staff development was broken into four groups: PK – 2, 3 – 5, 6 – 8, and 9 – 12. The schedule should take into consideration of having staff development in the mornings and workdays in the afternoon. More time should be given to learn about web design, with less time on GradeSpeed. There should be time scheduled for each department to meet, making note of the available technology. CPR should continue for those who need training. We should look into having a special education rotation. Questions were asked about what is required for staff development—CPS, bullying, CPR, etc.

Mr. Blincoe gave an update about the Early College Start going well.

There was not any old business to discuss.

New business included the following comments: Mr. Blincoe stated that he has an opportunity to go to another district (Brownwood ISD). Electrical work in concession stands would be during the summer. There was a brief discussion about having a cleaning service.

The meeting adjourned at 5:10 PM.
