WHEREAS, the Stockdale Independent School District is located in Wilson County and

WHEREAS, this District has become aware that Gordon Clifford Swenson has applied to the Texas Commission on Environmental Quality, under the registration number 710926, to dump domestic human waste from portable toilets and septic tanks within Wilson County; and

WHEREAS, the Texas Commission on Environmental Quality is currently accepting written comments regarding the Gordon Clifford Swenson permit, registration number 710926; and

WHEREAS, the dumping of domestic waste presents a danger to the health of Wilson County's population, could contaminate drinking water, would create noxious odors that would be detrimental to Wilson County; and

WHEREAS, the risks associated with dumping domestic waste within the County's boundaries could result in other serious health risks;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE STOCKDALE INDEPENDENT SCHOOL DISTRICT:

- 1. That the Board of Trustees opposes the Texas Commission on Environmental Quality application number 710926 and asserts that said application should be denied. Additionally, the Board of Trustee respectfully requests a public hearing to prevent the site registration.
- 2. That the Board of Trustees authorizes the Superintendent to submit this resolution to Bridget C. Bohac, Chief Clerk (Mc-105) P.O. Box 13087, Austin, Texas 78711-3087 as our official comments regarding application number 710926 by December 31, 2012; to sign the Save Nixon Petition on behalf of this District; and to take any other lawful actions to prevent the dumping of hazardous waste on properties adjacent to or within the proximity of District campuses.
