Call to order at 6:30 p.m.

- \$.30 for the purpose of payment of principal and interest on debts.

A motion was made by Barry Osborne and seconded by Terri Dugi to accept the recommendation. The motion passed unanimously.

Mr. Darilek made a recommendation to approve the Tax Discounts as follows;

• October (3%), November (2%), and December (1%).

A motion was made by Teri Wolff and seconded by Teri Dugi to approve the Tax Discounts as presented. The motion passed unanimously.

Audience with people wishing to address the Board: No one addressed the Board

Mr. Darilek made a recommendation to approve the 2016-2017 Athletic Handbook, with adjustments to dates as discussed. A motion was made by Barry Osborne and second by Teri Wolff to accept the recommendation. The motion passed unanimously

A motion was made by Barry Osborne and seconded by Mauro Monita to approve the previous Board Minutes as presented. The motion passed unanimously.

Becky Stewart, Business Manager, reviewed the current Financial Reports and Stockdale ISD bills provided to the Board, and answered questions concerning the reports.

Roxanne Moczygemba reviewed the Policy Update 105. Teri Dugi made a motion that the Board add, revise or delete (LOCAL) policies as recommended by TASB Policy Service and according to the Instruction Sheet for TASB Localized Policy Manual Update 105. The motion was seconded by Teri Wolff. The motion passed unanimously.

Roxanne Moczygemba reviewed Local District Update 2016-2. Teri Dugi made a motion that the Board adopt FFA(LOCAL): Student Welfare-Wellness and Health Services, as presented. The motion was seconded by Teri Wolff. The motion passed unanimously.

Mr. Darilek made a recommendation to approve the Resolution of the Board Regarding Hazardous Traffic Conditions. A motion was made by Mauro Monita and seconded by Barry Osborne to accept the recommendation. The motion passed unanimously.

Mr. Darilek made a recommendation to approve the 2016-2017 Appraisal Calendar as presented. A motion was made by Teri Wolff and seconded by Teri Dugi to accept the recommendation. The motion passed unanimously.

CLOSED SESSION: (Texas Govt. Code Section 551.071, 551.074 and 551.072 et seq) The Board was called into closed session at 7:05 p.m. The Board reconvened to open session at 7:45 p.m.

• Based upon the Superintendent's briefing in Closed Session, Teri Wolff made a motion to uphold the Superintendent's decision not to accept resignation of Mrs. Shannon Brockman at this time, and to authorize the Superintendent to take whatever actions are necessary in order to file a written complaint against Mrs. Brockman on behalf of this Board with The State Board for Educator Certification, seeking sanctions against her, pursuant to section 21.210 of The Texas Education Code, should Mrs. Brockman fail to perform her current employment contract with this District. The motion was seconded by Tanner Voelkel. The motion passed unanimously.

- Mr. Darilek advised the Board that Ag Teacher; Josh Heimann has been seeking land to house show animal pens. He has contacted the City of Stockdale and reached an agreement for portion of five-acre tract, located at 11979 CR 401, Stockdale Texas with a long term lease agreement

RESOLUTION OF THE BOARD REGARDING HAZARDOUS TRAFFIC CONDITIONS

WHEREAS, Education Code 42.155(d) allows the Board of Trustees of **Stockdale ISD** to obtain supplemental state funding for transporting regular, otherwise ineligible students who live within two miles of their school but who would be subject to hazardous traffic conditions if they walked to school;

WHEREAS, the TEA handbook on School Transportation Allotments requires the Board to adopt language providing the definition of hazardous traffic conditions applicable to the District and identifying the specific hazardous areas for which such funding is requested;

WHEREAS, the Board acknowledges the Education Code 42.155(d) provisions stating that a hazardous condition exists where no walkway is provided and students must walk along or cross a freeway or expressway, an underpass, an overpass or a bridge, an uncontrolled major traffic artery, an industrial or commercial area, or another comparable condition;

NOW THEREFORE BE IT RESOLVED that the Board of Trustees of **Stockdale ISD** has determined that a hazardous condition exists because there is no walkway where students must walk along or cross: **Highway 123 and Highway 87/97**;

And the Board of Trustees of **Stockdale ISD** has identified the following specific hazardous areas in which such conditions exist:

- 1. The blocks bounded by Highway 123 South, Mayer Street, South Eleventh Street, East Street, Twelfth Street and Business 87 East.
- 2. The blocks bounded by Highway 123 North, East Wheeler Street, West Free Timber Street, and West Wheeler Street.
- 3. The blocks bounded by West Main Street crossing Highway 87/97 and South Cemetery Street.
