The Board of Trustees of the Stockdale Independent School District held a special called meeting on Wednesday, August 28, 2019 at 6:30 p.m.

Call to order at 6:30 p.m.

President Sal Urrabazo reserved the right to call a short recess if he deemed necessary. He advised all present to refrain from the use of tobacco products on the school grounds and during the meeting. Mr. Fuller made a recommendation to accept the Education Foundation donation of \$3,650.00. a motion was made by Tanner Voelkel and seconded by Mauro Monita to accept the recommendation. The motion passed unanimously.

Mr. Fuller reviewed the insurance proposals received from LaVernia Insurance and TASB for the Property Insurance. Mr. Fuller made a recommendation to continued coverage with TASB. A motion was made by Teri Wolff and seconded by Tanner Voelkel to accept the recommendation. The motion passed unanimously.
