Each person spoke to the board on and had comments on the guardian program coming to Stockdale ISD. All of them were encouraging the program and spoke on all of the benefits of the program coming to our district.

CJ Urrabazo made a motion to approve the previous Board Minutes as presented. The motion was seconded by Tanner Voelkel and passed unanimously.

Discussion of bringing the Guardian program to Stockdale ISD. No action was made, but further discussion will be held in the near future regarding the program.
