# STOCKDALE INDEPENDENT SCHOOL DISTRICT REGULAR CALLED MEETING August 14, 2023

Board of Trustees of the Stockdale Independent School District held a regular meeting on Monday, August 14, 2023.

Board members present: Tanner Voelkel, Teri Dugi, Mauro Monita, Blaine Akin, Sherry Lambeck, Reuben Johsnon and CJ Urrabazo.

Also present were Superintendent, Todd Deaver; Business Manager, Nichole Gordon; Administration Secretary, Erica Haley; Chief of Security, Larry Haecker and Walsh Gallegos representative, Josh Haney.

Call to order at 6:30 p.m.

President Tanner Voelkel reserved the right to call a short recess if deemed necessary. He advised all present to refrain from the use of tobacco products on the school grounds and during the meeting. He also reserved the right to call the Board into Closed Session under Texas Government Code Section 551.001 through 551.088, Subchapter D and E.

#### Hold a Tax Rate Hearing and Adoption of the 2023 Tax Rate

Walsh Gallegos representative, Josh Haney, reviewed Certified Taxable Values and answered questions regarding the Tax Levy. Comparisons of local values were discussed.

- Mr. Deaver made a recommendation to appoint Business Manager Nichole Gordon as the
  designated officer responsible for calculating and reporting the no-new-revenue tax rate and the
  voter approval tax rate as determined by state law. A motion was made by CJ Urrabazo to
  approve the recommendation and seconded by Reuben Johnson. The motion passed unanimously.
- Mr. Deaver made a recommendation to accept the certified and supplemental appraisal rolls for Tax year 2023 for SISD. A motion was made by Sherry Lambeck and seconded by CJ Urrabazo to accept the recommendation. The motion passed unanimously.
- Mr. Deaver made a recommendation to adopt the Resolution of the Board to Set Tax Rate for 2023 at \$.976800, to be assessed and collected by the duly specified assessor and collector as follows:
  - \$ .669200 for the purpose of maintenance and operations, and
  - \$ .307600 for the purpose of payment of principal and interest on debts. A motion was made by Teri Dugi and seconded by Sherry Lambeck to accept the recommendation.

The motion passed unanimously.
